



# *Otter 100 Second Shopping Spree Contest*

## **FULL RULES & REGULATIONS**

**How to Enter:** The contest starts on January 5<sup>th</sup>, 2023 and closes on February 1<sup>st</sup>, 2023 (the “Contest Closing Date”).

### **Ways to Earn Entries:**

1. Entries will be earned by submitting a photo of your receipt from any purchase made in an Otter Co-op Food Store between January 5<sup>th</sup>, 2023 – February 1<sup>st</sup>, 2023 to the online entry form.

### **2. No Purchase Necessary method of entry:**

*a.* To obtain **1 entry** without making a purchase, mail in your name, address and phone number as well as a reasonable hand drawn facsimile UPC from any Co-op Gold Product to: ***Otter Co-op BCLC 100 Second Shopping Spree Contest, 3650B – 248<sup>th</sup> Street, Aldergrove, BC V4W 1X7.*** (Only mail in entries will be accepted. Reproduced facsimiles will be disqualified).

*b.* Mail-in submissions must be received by January 28<sup>th</sup>, 2023. Multiple “no purchase necessary” entries can be earned provided that each submission is sent in a separate envelope (multiple entries received in the same envelope will be disqualified).

### **Could my entry into a Contest be refused or rejected?**

Your entry into a Contest could be refused or rejected if:

1. you attempt to enter the Contest in an unauthorized fashion;
2. your entry contains false or misleading information, or is late, falsified, illegible, damaged or incomplete or otherwise irregular;
3. you enter more than once per receipt
4. your entry is submitted using robotic, automated, programmed, or other illicit means; or
5. your entry is not in compliance with our General Contest Rules.

In addition, Otter Co-op reserves the right to refuse any entry for any other reason as it may determine.

## **Participating Products:**

Any purchase made within an Otter Co-op Food Store is eligible for this promotion, with the exception of tobacco, lottery, prescriptions, gift cards and stamps.

## **The Prize:**

There is a total of THREE grand prizes available to be won, consisting of a 100 second shopping spree in each of Otter Co-op's three food stores. Full rules for the shopping spree are posted at [www.otterco-op.crs](http://www.otterco-op.crs). A waiver will be required to be signed prior to the awarding of the prize. THREE prizes are available to be won in the PROVINCE OF BRITISH COLUMBIA. Prizes are non-transferrable, have no cash value, and may not be exchanged.

## **Prizing Conditions:**

- Shopping spree date will be determined with winner, Food Store Manager and Otter Co-op Marketing at a mutually agreed upon date
- Shopping spree will be timed for 100 seconds beginning at the front of the store. At the end of the 100 seconds, the winner will immediately stop placing food items in the cart and the items will be tabulated.
- No items from hardware, fashions or general merchandise are included in the shopping spree. If any of these items are in the cart, those items will be excluded from the total received.
- Limit of six (6) meat items in total, two (2) each of from the following departments: meat, poultry and seafood.
- Limit of two (2) over the counter medications.
- Winner may only take any two (2) of a like kind. For instance, two cans of spaghetti sauce, two bags of dog food, two jugs of milk, etc. If more than two (2) are taken, those items will be excluded from the total received.
- The following items are not included in the spree; prescriptions, tobacco, gift cards, lottery or any other non-food items.
- Winner will shop alone and not receive any assistance from any other person including Co-op employees.
- Winner agrees to have their name and likeness used by Co-op for advertising and promotional purposes.
- Patronage does not apply to any part of the shopping spree.
- Winner is not allowed to shop in store rooms, walk-in coolers, prep areas or any other area designated to Co-op employees.
- No items from the shopping spree may be returned or exchanged for any reason. Items are not available for cash value.
- A 30-second notice and 10-second notice/countdown will be announced.
- Any items that fall out of the cart, will not be included in the prize.
- The winner is permitted to tour the store prior to the spree. Only one shopping cart can be filled at a time. Should the cart become full, the spree participant must return to the front of the store to retrieve another empty cart.
- No items from the grocery spree paid for by Co-op may be returned for any reason. Items are not available for cash value.
- Participant agrees to have their name and likeness used by Co-op for advertising and promotional purposes.
- Grocery Spree Shopper must be 19 years of age or older and sign a release, absolving Co-op of any liability. Meaning neither party is responsible for any injuries the participants may bring upon themselves during the spree. These would include falling or strains due to lifting or running.

**Eligibility:** The sponsor of this contest is Otter Farm & Home Co-operative ("Sponsor"). To be eligible, you must be a resident of British Columbia in the PROVINCE OF BRITISH COLUMBIA as at the Contest Starting Date. You are NOT eligible if, at any point during this time, you are (or you

live with) an employee, representative or agent of the Sponsor or their affiliates or licensees, or advertising or promotional agencies.

**The Draw:** Prize pool will be consolidated between participating locations. Prize will be drawn by the Marketing team from the finalist prize pool on February 6<sup>th</sup>, 2023 at 10:00AM.

### **How can a potential winner become a winner?**

To be declared a winner, a potential winner:

1. must correctly answer, without assistance, a time-limited, mathematical skill-testing question to be administered by Otter Co-op;
2. must be in compliance with these General Contest Rules;
3. must sign and return, within any designated time period, a release of liability and consent to publicity form and any other documentation as reasonably required;
4. may be required to provide proof of identification to confirm eligibility or to claim a prize, or provide proof that he or she is the authorized Otter Co-op membership holder of any account associated with the selected entry.

### **Can Otter Co-op cancel or amend a Contest?**

Otter Co-op may cancel, modify, or suspend any Contest or amend our Contest Rules for any reason whatsoever. For example, if for any reason a Contest is not capable of running as originally planned, Otter Co-op may adjust any of the dates, timeframes or other Contest mechanics, or suspend or cancel the Contest.

### **Will I appear in any publicity if I am a winner?**

If you are a winner, Otter Co-op may require you to appear in publicity related to the Contest.

By accepting a prize:

1. you grant to Otter Co-op the irrevocable right to record, photograph or otherwise capture or document you, your likeness, your voice, or any statements you make regarding the Contest or the prize, by any available means;
2. you agree that any such captured material, together with your biographical information, such as name or place of residence, or your Entry Material (collectively, all such materials, the "**Publicity Material**"), may be used by Otter Co-op or their respective licensees, successors, or assigns (collectively, the "**Publicity Parties**") in any media, whether now known or later devised, worldwide and in perpetuity, for advertising or promotional purposes related to the Contest or any similar contest. Any such use of the Publicity Material may include the reproduction, modification, adaptation, translation or creation of derivative works from your Entry Material;
3. you acknowledge that the Publicity Parties shall not be required to compensate you, notify you, or request your permission in connection with their use of any Publicity Material, unless otherwise prohibited by law; and
4. you waive any rights that you may have or that may otherwise exist in connection with any use of the Publicity Material by any of the Publicity Parties, including any moral rights in any such Publicity Material.

**Limits of Responsibility:** By entering this contest, the winner acknowledges and agrees that Otter Farm & Home Co-operative, their respective affiliates, agencies, and their respective officers, directors, employees and agents shall have no liability and the contest winner hereby agrees to release them and hold them harmless from any liability arising from or relating to this contest or the awarding or use of the prize. By entering this contest, you consent to the Contest Sponsor and/or their

respective affiliates using the personal information submitted with your entry for the purpose of administering this Contest and for the purposes of contacting you in the future regarding their other promotions and product and/or service offerings, and our information may be shared among the Contest Sponsors and their respective affiliated companies for these purposes, subject to compliance with applicable privacy legislation.

**Other Rules:** The Sponsor will not engage in any correspondence except with the potential winner. The decisions of the Sponsor will be final and binding on all entrants. By entering, each entrant agrees to abide by the Official Rules and the decisions of the Sponsor which shall be final and binding in all matters related to this contest. All entries become the property of the Sponsor. The Sponsor shall not bear any liability for the loss, theft or misuse of the Prize, or any personal damage, personal injury or misfortune in any way attributable to this contest or the Prize. By entering, winner grants the Sponsor the right to use their name and/or likeness, without further compensation, in any advertising or publicity. Contest is subject to all federal, provincial, and municipal laws. Void where prohibited. The Sponsor reserves the right to terminate this contest or to amend these contest rules at any time without notice if any factor interferes with the proper conduct of the contest as contemplated by the Rules.
